Definition: To perform a variety of semiskilled work in the removal of urban blight, maintenance of streets, curbs and gutters, rights-of-way, signs, concrete repair, and street painting.

Distinguishing Characteristics: This is trainee class in the Street Maintenance Worker series. This class is distinguished from the Street Maintenance Worker I by the performance of the more routine tasks and duties assigned to workers in this series. Employees at this level are not expected to perform with the same independence of direction and judgment on matters related to established procedures and guidelines as are positions allocated to the I level. Since this class is typically used as a training class, employees may have only limited or nondirectly related work experience. Employees typically work under immediate supervision while learning job tasks.

Supervision Received and Exercised: Receives immediate supervision from the Safety and Training Administrator and technical supervision from higher-level Street Maintenance positions.

Examples of Duties: Duties may include, but are not limited to, the following:

- 1. Perform graffiti abatement using multiple techniques, including scrubbing, scraping, repainting, and applying graffiti remover.
- 2. Remove and/or lift shopping carts and abandoned materials and transport to the Municipal Operations Center.
- 3. Assist with the maintenance and repair of the public right-of-way, including painting, construction, and installation of streets, parking lots, and traffic-control signs and striping; concrete repair, construction, and installation work; repaving, patching, overlaying, pothole repair, and crack sealing of asphalt; laying out and installing traffic signs and pavement markings.
- 4. Handle minor complaints and answer basic questions from businesses and the public.
- 5. Make minor adjustments on service equipment; maintain tools and equipment in working order.

Minimum Qualifications:

Knowledge of: Common tools and materials used in street maintenance; basic repair and maintenance procedures and practices; and safe work practices and

policies.

Ability to: Perform minor maintenance activities related to area of assignment; use a variety of tools related to area of assignment; communicate clearly and concisely, both orally and in writing; understand and follow oral and written instructions;

establish and maintain effective working relationships with those contacted in the course of work; use a variety of tools related to street maintenance; learn to operate

a variety of maintenance equipment; and perform heavy manual labor.

Experience and Training Guidelines: A combination of relevant education, experience, and training that will satisfy the required minimum qualifications,

knowledge, and abilities.

Six months of experience in construction or field maintenance work. Education

equivalent to the completion of the 12th grade.

Required Licenses or Certificates: Possession of a valid California Class C Driver License at the time of appointment and maintained through the duration of

employment.

Working Conditions: Preemployment and periodic respiratory examinations may be

required for this classification.
