## RENTAL HOUSING COMMITTEE RESOLUTION NO. RHC-42 SERIES 2021

## A RESOLUTION OF THE RENTAL HOUSING COMMITTEE OF MOUNTAIN VIEW ADOPTING AN ANNUAL GENERAL ADJUSTMENT OF 2% FOR 2021

WHEREAS, the Community Stabilization and Fair Rent Act (CSFRA) requires the Rental Housing Committee to announce by June 30, 2021 the amount of the Annual General Adjustment that will be effective as of September 1, 2021; and

WHEREAS, the Annual General Adjustment shall be equal to 100% of the percentage increase in the Consumer Price Index (All Urban Consumers, San Francisco-Oakland-San Jose region, or any successor designation of that index that may later be adopted by the U.S. Bureau of Labor Statistics ("CPI")) as reported and published by the U.S. Department of Labor, Bureau of Labor Statistics, for the 12-month period ending as of March of the current year. Since the CPI San Francisco-Oakland-San Jose region is no longer published, the Rental Housing Committee has adopted a successor index, namely the San Francisco-Oakland-Hayward CPI-U (San Francisco Area) for determining the Annual General Adjustment. The Annual General Adjustment shall be rounded to the nearest one-tenth of a percent (0.1%); and

WHEREAS, in no event shall the Annual General Adjustment be less than 2% or more than 5%; and

WHEREAS, the CPI for the period of February 2020 to February 2021 is 1.6%; and

WHEREAS, the Rental Housing Committee held a publicly noticed meeting on May 17, 2021 and discussed and considered the CPI for February 2020 to February 2021;

NOW, THEREFORE, BE IT RESOLVED by the Rental Housing Committee that the Annual General Adjustment for 2021 is 2%, and it shall be effective September 1, 2021.
