Exhibit: A. CSFRA Regulations, Chapter 7, Procedures for General Annual Adjustments

Community Stabilization and Fair Rent Act Regulations Amendments to Chapter 7, Procedures for Annual General Adjustments

Subsection C.2.f of Chapter 7 of the CSFRA Regulations is amended to read:

"f. Other Hardship. Any Tenant household which: (i) does not qualify under the definitions of hardship included in Subsections C.2.a through C.2.e of this Chapter 7; and (ii) demonstrates other extenuating circumstances may request such circumstances be considered hardship for the purposes of Subsection C.6 of this Chapter 7."
