Exhibit: A. CSFRA Regulations, Chapter 5, Hearing Procedure

Community Stabilization and Fair Rent Act Regulations

Amendment to Chapter 5—Hearing Procedure

Section C of Chapter 5 of the Community Stabilization and Fair Rent Act (CSFRA) Regulations is amended to add Subsection 8 as follows:

"8. Prehearing Motions and Accommodation Requests. Prior to the Hearing, the Parties may submit for consideration prehearing motions and requests for accommodation. Either: (1) the Hearing Officer; or (2) the Chair of the Committee, with the assistance of the Committee's legal counsel, is authorized to issue decisions and determinations on any prehearing motions and requests for accommodation. As used in this Subsection 8, "requests for accommodation" shall include, but shall not be limited to, requests for reasonable accommodation submitted pursuant to the Americans with Disabilities Act (42 U.S.C. § 12132)."
