A RESOLUTION OF THE RENTAL HOUSING COMMITTEE  
OF THE CITY OF MOUNTAIN VIEW  
TO FOLLOW THE MOUNTAIN VIEW CITY COUNCIL CODE OF CONDUCT AND  
RELATED PERSONAL CODE OF CONDUCT AS WELL AS THE  
COUNCIL ADVISORY BODIES HANDBOOK

WHEREAS, the Rental Housing Committee (RHC) held a publicly noticed meeting on April 24, 2023 and discussed the adherence to the Mountain View City Council Code of Conduct and related Personal Code of Conduct as well as the Council Advisory Bodies Handbook; and

WHEREAS, Section 1709 of the Community Stabilization and Fair Rent Act (CSFRA) and Section 46.9 of the Mobile Home Rent Stabilization Ordinance (MHRSO) authorize the RHC to establish rules and regulations for administration and enforcement of the CSFRA and the MHRSO, including the adoption of rules governing conduct of RHC members; and

WHEREAS, pursuant to Section 1709(k) of the CSFRA, the RHC is an integral part of the government of the City but exercises its powers and duties independent from the City Council, and the RHC desires to confirm that its members are subject to the City Council Code of Conduct and the related Personal Code of Conduct, a compilation of policies and requirements designed to ensure legal and ethical conduct, as well as the Council Advisory Bodies Handbook; now, therefore, be it

RESOLVED: that the Rental Housing Committee is hereby subject to the City Council Code of Conduct and related Personal Code of Conduct as well as the Council Advisory Bodies Handbook as set forth in Exhibits A and B of this Resolution.
