A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOUNTAIN VIEW
AMENDING THE CITY OF MOUNTAIN VIEW MASTER FEE SCHEDULE





Endnote 20:

Projects that are larger, more complex, and/or will require a City Council public hearing will be subject to an hourly fee for applicable staff time in order to be fully cost-recovered. This cost-recovery hourly rate applies to projects that require staff support beyond the scope of work included in the development of the basic fee(s) and will be based on the time required to process the entire project. The applicant will be notified if this fee is applicable to their project. The fee is collected through an advance deposit with subsequent fee deposit(s) collected should additional staff time be required beyond the initial deposit, and any excess funds will be returned to the applicant upon project completion, closure, or withdrawal. The Community Development Director is authorized to establish guidelines to implement this cost-recovery fee and deposit.

Endnote 76:

Hourly rate of staff time when a resolution or City Code indicates the fee is hourly.

- ² Employee labor agreements expire on June 30, 2024 and negotiations of new contracts are currently in progress and expected to conclude prior to budget adoption in June. Hourly rates include a projected moderate COLA. Staff recommends the City Council grant the Finance and Administrative Services Director the authority to modify the hourly rate in accordance with any future salary or benefit adjustment to reflect actual cost.
- ³ Cost-recovery development projects submitted prior to August 24, 2024 are subject to the existing cost-recovery fee (with an annual 4% COLA adjustment) until project completion.
- ⁴ Fee was removed from the hourly rate of Planning, Building, and Housing staff and is proposed to be added as a separately listed fee for clarity as this will apply to all department staff as part of the cost-recovery project. This is not a new fee.

Water: Future wholesale water rate increases would be passed through by increasing the City's Water Quantity Charges by the weighted average wholesale rate per ccf of water. For example, if the weighted average wholesale rate increased by \$0.30 per ccf, then all of the City's Water Quantity Charges would also increase by a corresponding \$0.30 per ccf. In addition, the City would also pass through an annual inflation adjustment to both its Fixed Service Charges as well as the share of the Water Quantity Charges that recover costs for expenses other than wholesale water rates. The Fixed Services charges pass-through adjustments will be based on the weighted average percentage cost increase accounting for both: (a) the proposed increase in SFPUC and SCVWD rates; and (b) the percentage change in the February CPI. The annual pass-through rate adjustments for inflation would also apply to the Fireline Standby Rates and Backflow Prevention Rates.

Wastewater: The annual pass-through adjustments will be based on weighted average percentage increase accounting for both: (a) the proposed increase in Treatment Plant operating costs from the base Fiscal Year 2024 25; and (b) the percentage change in the February CPI.
